

### The AUnauthentic≅ Hoopes Crest



There is no official coat of arms for the Hoopes family, in our case meaning that the crest is not registered with the College of Arms in England as was verified by members of the Hoopes Family Organization prior to publication of *The Hoopes Family Record*, as excerpted from Volume 1:

In 1969, Francis S. McIlhenny, Jr. wrote to the College of Arms in England to inquire as to the authenticity of the Hoopes family crest. In February 1970, the Richmond Herald of Arms of the College of Arms replied stating that none of the two or three crests or coats-of-arms purported to belong to the Hoopes family was registered with the College of Arms. These crests were, therefore, not authentic. Since the early Hoopes males were yeomen [common men, not royalty], they obviously did not bear arms. The only explanation we have for the fact that such coats-of-arms do exist is the suggestion that some of the arms mongers found willing clients.

### Description of the AUnauthentic≅ Hoopes Family Crest

Even though the Hoopes family crest is not authentic, because it is displayed by some members of the Hoopes family the editors describe here, in heraldic terms, the Hoopes family crest, as recorded in a 1928 publication titled *American Families*:

Arms: Gules, a fesse ermine between three lions= heads erased argent within a bordure azure charged with two crescents in chief and a mullet in base of. Crest: On a plate a Cornish chough proper. Motto: Amo (I love). This description is interpreted as:

Arms: Red (the background behind the lions= heads in red), with a horizontal bar through the middle of the shield with the conventional symbols of ermine (three black dots in triangular form with an elongated diamond below the middle of the base of the triangle) on a white background between three lions= heads, two above the bar and one below, the heads being silver in color. (The word Aerased≅ means that it is just the head without any body of the lion.) Around the center section of the shield is a blue border in which at the top (Ain chief≅) are two crescents in gold. A crescent means not only a crescent but a crescent with the points pointing up. At the bottom (Ain base≅) a five pointed star in gold. Actually, a mullet is the rowel [the round spiked portion] of a spur. Crest: A plate is a round silver object. A Cornish Achough≅ is a bird of the raven species, the kind of the crows. Proper means that the raven is in its natural color, black. The helmet is slate gray with red showing through the framing is silver and red.

This interpretation has been faithfully and beautifully rendered in color by Patricia Hoopes. She agreed to let me share the story of her reproduction of the crest:

In 1976 when I was home from college for Thanksgiving, my father, who never asked for ANYTHING, asked me if I would use my artistic ability to create a color version of the Hoopes family crest as described in the Family Record. I feigned vague interest and protested that I was extremely busy with exams, etc. Secretly, for many reasons, I was thrilled that he asked for it. When I returned to school I got right on it. At Christmas break he asked again, almost apologetically. Again I gave him a few excuses about time, which he accepted.

However, I had produced the crest for his Christmas gift. Everyone but Dad knew about the gift and as he began to open it, we were all silent. When he saw the framed, colored crest he began to cry. I had never seen my father cry. His joy at that moment is one of the greatest gifts he ever gave me.

I received the crest back after both of my parents died. Recently, with the wonders of modern technology, I was able to scan and improve upon the quality of the crest I created for Dad. It was originally produced on parchment which has yellowed with time, giving the crest a very distinctive background.

I would like to make it available to others who may be interested...

Patricia says she will be glad to email the electronic version of the crest free of charge to any family members who=d like to have it. Although we make every attempt to avoid any sort of commercial endorsement in the newsletter, I will mention that Patricia can also put the crest on a pillow or T-shirt for sale as shown on her website, patriciahoopes.com.

Patricia also suggested that we might like to use the crest on our website. At first, I thought we shouldn=t - since it=s not authentic and I don=t like the idea of faking a royal connection. But then it has been an emblem accepted by members of the family since 1928 - and I guess it could save us from designing a family logo. What do you think? Does anyone have information regarding the existence of any African-American Hoopes ancestors? Here is an excerpt from an email sent by Mary Anne Hoopes of Alexandria, VA:

I am pursuing some family information that my dad=s grandparents were partly African American - or Ahad Negro features≅ as my father said. They were William Martin Hoopes, b July 1848 in August, Carroll County, OH, d 1934, and his wife Eliza Harrison, b 1858 NFI. I would love to track this down but have had no luck thus far. They reported themselves AWs≅ [white] in the 1880 census. If you know of any cousins with information that may assist can you please forward my query to them or their addresses to me?

I asked Mother [June Hoopes] about this and she responded that in the early 1960s she had asked a friend still living there if there were any Hoops or Hoopes buried in Borger, Texas [where we lived for many years] and was told there was one Hoops but she was sure it had nothing to do with us be-cause he or she was black. She didn=t pursue it further because the Hoopes family were known to be staunch anti-slavers, except for one who refused to manumate his slaves and moved to Mississippi. In checking again, she learned that one Ethel Hoops was born 1/8/1897 and died 1/2/1937 and is buried in a cemetery in Amarillo, Texas [50 miles from Borger].

Vol III p 1090 - **11408. Robert Thomas Hoopes** was married to JUNE KATHERINE VOLZ (my mother went by June, not Katherine as underlined in the book). She was born in 1926 (not 1925) and died September 13, 1991 in Two Rivers, WI of pancreatic cancer. June was irrepressibly cheerful and was adored by her children (each of whom is sure he was the favorite!). Hers is a legacy of hugs, smiles, joy, acceptance and optimism. Robert died August 18, 1985 of a heart attack. Affectionately known to his kids as "R.T." In WWII, due to his Culver connections, Robert was summoned to London from Iceland and recruited into an elite intelligence group connected with those Army personnel involved in translating the German code and distributing it to President Roosevelt, Winston Churchill and Army field personnel. "Ultra" was the code name for the operation that involved breaking the supposedly "unbreakable" German code. (For a fascinating description of this war-winning effort, read "The Ultra Secret," by General F.W. Winterbotham, Dell Publishing, 1974). At the time of his death, Robert had been preparing to participate in an oral history project produced out of the University of Wisconsin. The producers were documenting "untold" stories of some of the behind-the-scenes participants in the war.

Other survivors include three brothers: Milton of Boise, ID, Dean of Salina, KS and Paul of Glasco, KS; and two sisters: Pauline Lightcap of Offerle, KS and Dorothy Peck of Salina, KS. Ernie was devoted to his family, his church, and the many students and friends he had over the years... Through the continual example of his life he had a significant influence on all those who knew him. Ernie had many interests including gardening, playing the harmonica, helping with wheat harvest, golfing, and sports - especially football which he and his brother Milton played together at Lucas High School. Ernie enjoyed sharing these interests with his family, taking them camping in the mountains, and teaching his grandchildren golf and the harmonica. He is buried at Plains Cemetery in Plains, KS.

Vol. I, pg. 201: As printed under "654. EDWIN A. HOOPES", the id # of his fourth child, Caroline R. Hoopes, is incorrect. It should read "1804" rather than "1802".

{Rationale: The id# "1802" is associated with two different individuals on page 201 (Franklin B. Hoopes and Caroline R. Hoopes), whereas id# 1804 is missing from the sequence of numbers used. On page 395 of Vol. I, however, the id# 1804 is used for Caroline R. Hoopes. Therefore, the number shown on page 201 is probably a typesetting error.}

Vol. I, pg. 218: As printed under "**786. REBECCA H. NEWLIN**", the given name of Rebecca's mother is incorrect. It should read "Deborah" rather than "Rebecca".

{Rationale: The mother of id# 786 REBECCA H. NEWLIN is shown on page 117, Vol. I as id# "220. DEBORAH HOOPES". Compare the forename spelling used for id# 220 in the paragraphs for each of her children with write-ups in the fifth generation, specifically, id#'s 785, 786, 787 & 788. On page 218, Vol. I, under "785. ZERUAH NEWLIN", his mother's forename is Deborah. On page 218, Vol. I, under "786. REBECCA H. NEWLIN", her mother's forename is Rebecca. On page 218, Vol. I, under "787. JOHN NEWLIN", his mother's forename is Deborah. On page 219, Vol. I, under "785. SAMUEL HOOPES NEWLIN", his mother's forename is Deborah. Of the five places in the RECORD where the individual id# 220 is cited, four use the spelling "Deborah" vs one "Rebecca".}
